

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting September 19, 2013 Special Session to Address the FY 2014 District Budgets)

LEGISLATIVE ORDER NO. 13-347

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and


5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the
6 Council with the authority to "by majority vote, call for a special session"
7 (Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section
8 1.D.1.); and

9 WHEREAS, the Budget and Finance Committee has requested a special session on
10 September 19, 2013 to address the FY 2014 district budgets.

11 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a
12 special session on September 19, 2013 to address the FY 2014 district budgets.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 10TH day of
14 ~~SEPTEMBER, 2013~~ at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-
15 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
16 Article VI, Section 1(a) and 1(d) of the Constitution of the Tohono O'odham Nation, adopted by
17 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
19 June 18, 1934 (48 Stat.984).
