9		than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and
10	WHEREAS,	by Resolution No. 11-394, Ms. Veronica A. La Motte Darnell served as a pro
11		tempore judge of the Tohono O'odham Judicial Court with a term that expired
12		on August 31, 2013; and
13	WHEREAS,	the chief judge has submitted Ms. La Motte Darnell's resume, letter of interest,
14		and a letter of recommendation for her appointment as a judge pro tempore to
15		the Tohono O'odham Judicial Court; and
16	WHEREAS,	the Judiciary Committee, having legislative oversight of matters pertaining to
17		the Tohono O'odham Judicial Court, has interviewed Ms. La Motte Darnell and
18		reviewed her resume, letter of interest, and the chief judge's letter of
19		recommendation.
20	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
21		appoints Ms. Veronica A. La Motte Darnell to the Tohono O'odham Judicial Court
22		as a pro tempore judge for a six-year term commencing on the effective date of
