1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 13-265,**
2 **"Approving FY 2014 District Allocation and Apportionment of Gaming**
3 **Distribution to the Districts by equal distribution"; and**

4 **WHEREAS, the apportionment for each of the Districts by equal distribution is in the**
5 **amount of \$1,144,609.60; and**

6 **WHEREAS, the Sif-Oidak District Council on September 3, 2013 enacted Resolution No.**
7 **SODC 13-113, "Approving the Sif-Oidak District FY 2014 Gaming Revenue Budget**
8 **in the amount of \$1,144,609.60"; and**

9 **WHEREAS, on September 05, 2013, the Budget & Finance Committee of the Legislative**
10 **Council reviewed the Sif-Oidak District FY 2014 Gaming Revenue Budget.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
12 **hereby approve the Sif-Oidak District FY 2014 Gaming Revenue Budget as**
13 **attached in the amount of \$1,144,609.60**

14 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or**
15 **funding levels that it shall be approved by the Tohono O'odham Legislative**
16 **Council prior to any expenditures.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
18 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,085.60**
19 **FOR; 467.10 AGAINST; 393.80 [02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested**
20 **in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham**
21 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
22 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
23 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**


