

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving SAWRSA Purchased Equipment Insurance Budget for fiscal year 2014)**

**RESOLUTION NO. 13-351**

1 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Legislative Council authorized**  
2 **San Xavier Cooperative Association to perform maintenance for the completion**  
3 **of the bank stabilization of the San Cruz River; and**

4 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Nation purchased equipment**  
5 **and materials necessary for the project and the Nation assumes financial**  
6 **responsibility of the yearly insurance cost on such equipment; and**

7 **WHEREAS, pursuant to Section .309(a) of the Southern Arizona Water Rights Settlement Act**  
8 **of 1982 ("SAWRSA") the Tohono O'odham Nation (the "Nation") received**  
9 **\$15,000,000.00 to be held in trust by the Nation (the "SAWRSA Trust Fund"); and**

10 **WHEREAS, under Section .309 (b) of SAWRSA, the Nation may expend accrued Interest and**  
11 **dividends on the SAWRSA Trust Fund "for the subjugation of land, development**  
12 **of water resources, and the construction, operation, maintenance, and the**  
13 **replacement of related facilities on the Papago Reservation (now known as the**  
14 **Tohono O'odham Reservation) which are not the obligation of the United States**  
15 **under this (SAWRSA) or any other Act of Congress"; and**

16 **WHEREAS, the San Xavier Cooperative Association has agreed to pay for the yearly**  
17 **maintenance costs of the equipment and requests that the Nation pays for the**  
18 **yearly insurance cost per resolution No. 08-96; and**

19 **WHEREAS, the Equipment Insurance Budget qualify for the funding under the SAWRSA**  
20 **Trust Fund; and**

21 **WHEREAS, the San Xavier District has prepared the attached budget for Fiscal Year 2014 in**  
22 **the amount of \$4,221.00 and funded from the SAWRSA Trust Fund.**

23 **NOW, THEREFORE, BE IT RESOLVED:**

- 24 **1. The Tohono O'odham Legislative Council hereby approves the San Xavier**  
25 **Cooperative Association Maintenance and Operational Equipment**  
26 **Insurance Budget in the amount of \$4,221.00 for fiscal year 2014 in the**  
27 **form attached hereto.**

1                   2.     The Legislative Council appropriates the sum of \$4,221.00 from the  
2                                   SAWRSA Trust Fund to fund the Equipment Insurance Budget for fiscal  
3                                   year 2014.

4     **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes funding  
5                                   from the SAWRSA Trust Fund to cover the yearly insurance costs on the  
6                                   equipment.

7     The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>  
8     day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5  
9     FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the  
10    Council by Article VI, Section (d)(2) of the Constitution of the Tohono O'odham Nation, adopted  
11    by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
12    Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
13    the Act of June 18, 1934 (48 Stat.984).


