

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 13-355, "Approving the San Xavier District Budget
for Fiscal Year 2014")**

RESOLUTION NO. 13-356

1 **WHEREAS, the San Xavier District (District) Administration developed and prepared a**
2 **budget for fiscal year 2014; and**

3 **WHEREAS, the proposed FY 14 District budget was reviewed by the District Council and its**
4 **Finance Committee, and District Department Managers at several special**
5 **District Finance Committee meetings held on July 22, 24, 25, and August 5, 7,**
6 **2013; and**

7 **WHEREAS, the District Council intends to utilize its gaming revenues and general operating**
8 **funds to meet the projected amount outlined in the attached FY 14 budget; and**

9 **WHEREAS, the proposed budget amount of \$6,402,858.02 was reviewed with, and approved**
10 **by the citizens of the San Xavier District Community who were present at the**
11 **August 24, 2013 Special Community meeting; and**


12 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee reviewed the**
13 **District's FY 14 on August 29, 2013, and recommended that it be forwarded to the**
14 **Tohono O'odham Legislative Council for approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the San Xavier District FY 14 budget in the amount of \$6,402,858.02**
17 **that includes the gaming funds in the amount of \$3,530,868.47 and District**
18 **general operating funds in the amount of \$2,871,989.55.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **district Chairperson and any other designated official to expend and administer**
21 **the budget as attached, provided that any amendments affecting the funds or**
22 **funding level shall be submitted for further prior approval by the Tohono**
23 **O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
25 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
26 **FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
27 **Council by Article VI, Section 1(d) and Article IX, Article 7 of the Constitution of the Tohono**
28 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
29 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
30 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
