RESOLUTION NO. 13-357

1 **WHEREAS, the Tohono O'odham Legislative approved FY 2014 District Allocations and**
2 **Apportionment of Gaming Revenues to Districts by equal distribution; and**
3 **WHEREAS, a draft FY 2014 budget in the amount of \$1,144,609.60 was presented to the**
4 **Pisinemo District Council for review, comment and recommendations; and**
5 **WHEREAS, the draft FY 2014 budget was also taken out to the communities for review and**
6 **comments then brought back to the District Council for action; and**
7 **WHEREAS, the amount distributed to the Pisinemo District for FY 2014 is insufficient to**
8 **adequately address the needs of community members; and**
9 **WHEREAS, the Pisinemo District Council has made a decision to carry over remaining**
10 **funds from its Community budgets for FY 2012; and**
11 **WHEREAS, the respective communities and District Council have supported the FY 2014**
12 **District Budget to be distributed as follows:**

21 **the Pisinemo District FY 2014 budget in the amount of \$1,171,709.60.**

22 **BE IT FURTHER RESOLVED the Tohono O'odham Legislative Council hereby approves the**
23 **addition of FY 2012 Community Budget Carry Over's in the amount of \$27,100.00**
24 **to be added to the Pisinemo District FY 2014 Budget.**

25 **BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby authorizes the**
26 **District Chairperson and any other designated official to expend and administer**
27 **the budget as attached, provided that any amendments affecting the funds or**
28 **funding level shall be submitted for further prior approval by the Tohono**
29 **O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
31 **day of ~~SEPTEMBER, 2013~~ at a meeting at which a quorum was present with a vote of 2,689.2**

33 **the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham**
34 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
35 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
36 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
