(Approving FY 2012 Mining Royalty Carry Over in the amount of \$114,957.83)**


1 **WHEREAS, the Pisinemo District Council at a regularly scheduled meeting held on August**
2 **20, 2013 discussed its FY 2012 Mining Royalty Budget; and**
3 **WHEREAS, the Pisinemo District Council was provided information on balances remaining**
4 **within the FY 2012 Mining Royalty Budget; and**
5 **WHEREAS, the remaining balance of \$114,957.83 will assist the District to continue**
6 **providing much needed services and assistance for District members; and**
7 **WHEREAS, the District Administration has submitted a budget proposal to carry over the**
8 **remaining balance of \$114,957.83 from FY 2012 Mining Royalty Budget into FY**
9 **2014.**

10 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves**
11 **the request to carry over its FY 2012 Mining Royalty Budget into FY 2014 in the**
12 **amount of \$114,957.83.**

13 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **District Chairperson and any other designated official to expend and administer**
15 **the budget as attached, provided that any amendments affecting the funds or**
16 **funding level shall be submitted for further prior approval by the Tohono**
17 **O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
19 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
20 **FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
21 **Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
22 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
23 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
24 **16 of the Act of June 18, 1934 (48 Stat.984).**


