

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to amend Solid Waste Program Revenue Budget in the amount
of \$94,000.00 for FY-2013)

RESOLUTION NO. 13-360

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the**
2 **Solid Waste Management Program Budget 044-13-3525 through Resolution No.**
3 **98-236 and 05-558; and**

4 **WHEREAS, the Solid Waste Management Program Revenue Account has a balance sufficient**
5 **to cover the \$94,000.00 increase from fees for services and the sale of materials**
6 **for recycling; and**

7 **WHEREAS, the SWMP initially prepared a budget in the amount of \$350,000.00 that was**
8 **approved by Legislative Council Resolution No. 12-232 and amended by**
9 **\$160,000.00 with Legislative Council Resolution No. 13-132 for the FY-2013**
10 **budget account 044-13-3525; and**

11 **WHEREAS, the SWMP is experiencing higher volumes of solid waste for disposal; larger**
12 **amount of fuel to perform services; increased repair of equipment due to aging**
13 **of fleet; increased cost of tires; equipment damage due to poor road conditions;**
14 **a high incidence of arson of trash bins and overall, higher demand for SWMP**
15 **Services; and**

16 **WHEREAS, the Solid Waste Management Program Budget Amendment #2 to Budget 044-13-**
17 **3525 has been reviewed by the Legislative Agricultural and Natural Resources**
18 **Committee and the Legislative Budget and Finance Committee and recommend**
19 **its approval and adoption.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
21 **hereby approves the budget amendment #2 to increase the budget from**
22 **\$510,000.00 to \$604,000.00 for an additional \$94,000.00 from deposits of**
23 **program revenue for the Solid Waste Management Program FY-2013 Budget**
24 **Account 044-13-3525, from October 1, 2012 through September 30, 2013, in**
25 **accordance with the budget attached hereto.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
27 **Chairperson and any designated official to expend and administer the SWMP**
28 **Revenue FY-2013 Budget Account #044-13-3525, provided that any amendments**
29 **affecting the funds or funding level is submitted for further prior approval by**
30 **the Tohono O'odham Legislative Council.**
