

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the Legislative Branch Vehicle Policy)**

LEGISLATIVE ORDER NO. 13-364

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to delegate authority to the Council Chairperson and Vice-**
3 **Chairperson (Constitution, Article V, Section 4); and**

4 **WHEREAS, the Legislative Council has delegated to the legislative officers authority to**
5 **"[a]llocate funds, staff, and other resources for the effective operation of the**
6 **Legislative Branch" and to "[a]pprove Legislative Branch expenditures"**
7 **(Legislative Order No. 06-047)**

8 **WHEREAS, in 2005, the Council adopted an amended Legislative Branch Vehicle Policy to**
9 **regulate the use of Legislative Branch vehicles in a manner that protects**
10 **Legislative Council representatives and employees while traveling on official**
11 **business and defines procedures for requesting, using, and maintaining Branch**
12 **vehicles (Legislative Order No. 05-516); and**


13 **WHEREAS, the Legislative Branch administration has developed amendments to the**
14 **Legislative Branch Vehicle Policy for the Legislative Council's consideration;**
15 **and**

16 **WHEREAS, it is in the best interest of the Legislative Branch to adopt amendments to the**
17 **"Legislative Branch Vehicle Policy" as attached and dated for reference**
18 **September 2013.**

19 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it adopts**
20 **the amended "Legislative Branch Vehicle Policy" as dated for reference**
21 **September 2013**


22 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH day of**
23 **SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
25 **Article V, Section 4 and Article VI, Section 1(l) of the Constitution of the Tohono O'odham**
26 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
27 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
28 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
