1	WHEREAS,	the Legislative Council is vested with the authority to "consult, negotiate and
2		conclude agreements and contracts on behalf of the Tohono O'odham Nation
3		with Federal, State and local governments and other Indian tribes or their
4		departments, agencies, or political subdivisions, or with private persons or
5		organizations on all matters within the authority of the Tohono O'odham
6		Council" (Tohono O'odham Constitution, Article VI, Section 1(f)); and
7	WHEREAS,	the Legislative Council approved the FY 2014 Executive Branch Administrative
8		Lobby Budget, line item 7335 – Lobbying, which funds federal and state lobbying
9		services; and
10	WHEREAS,	the Nation's Chairperson, in consultation with the Appropriations Committee,
11		recommends that Triadvocates, LLC be retained as a governmental relations
12		consultant for matters involving State of Arizona legislative, administrative,
13		appropriations, lobbying, and agency activities, as well as State of Arizona local
14		and municipal governmental activities, that may affect the Nation in accordance
15		with the attached Governmental Relations Representation Contract with
16		Triadvocates, LLC ("Contract") for the period commencing October 1, 2013 and
17		ending September 30, 2014.
18	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
19		1. Approves the Contract with Triadvocates, LLC in the amount of \$180,000 for
20		the period commencing October 1, 2013 and ending September 30,
21		2014 in substantially the form attached hereto; provided that the Contract
22		shall be funded from the FY 2014 Executive Branch Administrative Lobby
23		Budget, line item 7335 – Lobbying, and

2. Authorizes the Nation's Chairperson to execute the Contract.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12^{TH} day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
