
1 **WHEREAS, by Resolution No. 12-405 the Nation approved an Attorney Contract with the law**  
2 **firm of Wilmer Cutler Pickering Hale and Dorr, LLP; and**  
3 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**  
4 **Contract; and**  
5 **WHEREAS, funding for this Attorney Contract will come from sources approved for such**  
6 **purposes by the Legislative Council; and**  
7 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**  
8 **Amendment No. 1 to the Attorney Contract and recommend approval by the**  
9 **Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to**  
12 **the Attorney Contract with the law firm of Wilmer Cutler Pickering Hale**  
13 **and Dorr, LLP, for FY 2013 substantially in the form attached hereto.**
- 14 **2. Funding for Amendment No. 1 shall come from sources approved for such**  
15 **purposes by the Legislative Council.**
- 16 **3. The Chairperson of the Nation is authorized to execute Amendment No. 1**  
17 **to the Attorney Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
19 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**

21 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**  
22 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
23 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
24 **the Act of June 18, 1934 (48 Stat.984).**
