1 **WHEREAS, the Gu-Vo District presented to the Tohono O'odham Legislative Council its**  
2 **budget for the 2014 Fiscal Year; and**

3 **WHEREAS, the Gu-Vo District was allocated Gaming Revenue in the amount of**  
4 **\$1,144,609.60; and**

5 **WHEREAS, the amount of \$1,144,609.60 from the Tohono O'odham Nation's Gaming**  
6 **Revenue has been allocated to the four (4) Communities and the Administration**  
7 **as follows:**


