11	WHEREAS,	the proposed budget amount of \$1,144,609.60 was received with and approved by
12		the citizens of the Hia-Ced District Community who were present at the August
13		17, 2013, monthly Community meeting; and
14	WHEREAS,	the Tohono O'odham Legislative Budget & Finance Committee reviewed the
15		District's FY 14 budget on September 11, 2013, and recommended that it be
16		forwarded to the Tohono O'odham Legislative Council for approval.

18		approves the Hia-Ced District FY 2014 Budget in the amount of \$1,144,609.60
