RESOLUTION NO. 13-377

1 **WHEREAS, at a regular session of the Tohono O'odham Legislative Council held on**
2 **September 19, 2013; and**

3 **WHEREAS, Baboquivari District Representatives presented the FY 2014 Budgets for the**
4 **Baboquivari District Administration/District Day, Artesia Little Tucson**
5 **Community, Fresno Canyon Community, Choulic Community, Cold Fields**
6 **Community, Topawa Community, South Komelic Community (see attached**
7 **budgets); and**

8 **WHEREAS, per Resolution #13-265, Equal distribution to Districts; and**

9 **WHEREAS, the Council has opted to split the distribution amount of \$1,144,609.60 with a**
10 **30%/70%; per Resolution No. 2013-B-87, Baboquivari District Administration**
11 **receives 30% in the amount of \$343,382.86, the 70% in the amount of \$801,226.74**
12 **to be divided by the six communities in the amount of \$133,537.79 per**
13 **community; and**

14 **WHEREAS, FY 2014 Budget for Baboquivari District Administration, Fresno Canyon**
15 **Community, Topawa Community will include carryovers as follows:**

- 16 **1. Baboquivari District Administration - FY 2008 to FY 2011 Carryovers**
17 **identified \$368,302.66, utilizing \$255,517.21, remaining balance of**
18 **\$112,785.45 to be used at a later date.**
- 19 **2. Fresno Canyon Community FY 2012 - Carryovers identified \$154,878.95**
20 **utilizing \$76,380.05, remaining balance of \$78,498.90 to be used at a later**
21 **date.**
- 22 **3. Topawa Community FY 2011 to FY 2012 - Carryovers identified**
23 **\$121,478.98, utilizing \$80,881.61, remaining balance of \$40,597.37 to be**
24 **used at a later date; and**

25 **WHEREAS, after review and discussion the Tohono O'odham Legislative Council approves**
26 **the FY 2014 budgets for the Baboquivari District Administration/District Day,**
27 **Artesia/Little Tucson Community, Fresno Canyon Community, Choulic**
28 **Community, Cold Fields Community, Topawa Community, South Komelic**
29 **Community in the amount of \$1,557,388.47.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reviewed,**
31 **discussed and approved the FY 2014 Budgets for the Baboquivari District**

4 BE IT FURTHER RESOLVED remaining carryovers in the amounts of \$112,785.45 for
5 Baboquivari District Administration \$78,498.90 for Fresnal Canyon Community
6 \$40,597.17 for Topawa Community to be used at a later date.

7 BE IT FINALLY RESOLVED that any modifications, amendments or changes in the amount of
8 funds shall be reviewed and approved by the Tohono O'odham Legislative
9 Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH
11 day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5
12 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the
13 Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,
14 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
15 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 16 of the Act of June 18, 1934 (48 Stat.984).
