

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Fiscal Year 2014 Budgets for Sells District Administration and its
Communities in the Amount of \$1,444,609.60)**

RESOLUTION NO. 13-382

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution 13-265 approved the FY2014**
2 **District Allocation and Apportionment of Gaming Revenues to Districts by Equal**
3 **Distribution in the amount of \$1,144,609.60 to each of the twelve districts; and**
4 **WHEREAS, Sells District Administration did inform the communities of the decrease in the**
5 **allocation to FY 2014 from FY 2013; and**
6 **WHEREAS, due to the decrease in the allocation, Sells District Council did approve to do a**
7 **non-transfer of unspent gaming revenue from Fiscal Year 2013 to the Gaming**
8 **Revenue Reserve Account with resolution #SD-70-13; and**
9 **WHEREAS, to help with the shortfall, Administration will carryover funds in the amount of**
10 **\$300,000.00 from the Fiscal Year 2013 gaming; and**
11 **WHEREAS, all communities did prepare and submit the attached community approved**
12 **budgets in accordance to their needs; and**
13 **WHEREAS, the District Administration and community budgets were presented to each of**
14 **the four communities and to the Sells District Council for their review and**
15 **approval; and**
16 **WHEREAS, Sells District Council did review and approve the Fiscal Year 2014 Sells District**
17 **Administration and Community budgets with Sells District Council Resolution**
18 **No. SD-85-13.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
20 **Sells District Fiscal Year 2014 Budget for Administration and it's communities as**
21 **submitted in the attached budgets and justifications for a total amount of**
22 **\$1,444,609.60 to be effective October 1, 2013.**

23 **BE IT FINALLY RESOVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Sells District Chairperson and any designated District Official to expend and**
25 **administer the budget as attached, provided that any modifications or**
26 **amendments affecting the funds or funding levels of the budget shall be**
27 **submitted for further prior approval by the Tohono O'odham Legislative**
28 **Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
30 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
31 **FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the**
32 **Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
34 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
35 **16 of the Act of June 18, 1934 (48 Stat.984).**


