## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving FY 2014 Federal Lobbying Contract with Dentons US LLP for Work Related to the Economic Development Delegation Budget)

**RESOLUTION NO. 13-383** 

1	WHEREAS,	the Legislative Council is vested with the power to "consult with the Congress of
2		the United States and appropriate federal agencies regarding federal activities
3		that affect the Tohono O'odham Nation all federal appropriation estimates and
4		projects for the benefit of the Tohono O'odham Nation before such estimates
5		and projects are submitted to Congress and other federal agencies"
6		(Constitution of the Tohono O'odham Nation, Article VI, Section 1(j)); and
7	WHEREAS,	the Legislative Council is further vested with power to "employ legal counsel for
8		the protection and advancement of the rights of the Tohono O'odham Nation"
9		(Constitution of the Tohono O'odham Nation, Article VI, Section 2(a)); and
10	WHEREAS,	it is in the Nation's interest to employ a lobbyist in Washington, D.C. to
11		effectively consult with the Congress and federal agencies; provide advice
12		regarding federal appropriations, legislation, and programs; and, when
13		authorized, act as a liaison between the Nation and the United States; and
14	WHEREAS,	the firm of Dentons US LLP is qualified to provide advice and representation as
15		the Nation's federal lobbyist; and
16	WHEREAS,	a federal lobbying contract, including an Exhibit A FY 2014 Billing Rates
17		Schedule and Exhibit B, the Engagement Agreement Letter and Terms of
18		Business (collectively, "Lobbying Contract"), has been negotiated with Dentons
19		US LLP ("the Attorneys") and has been reviewed by the Economic Development
20		Delegation.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
22		1. Approves the attached federal lobbying contract with the Attorney's in
23		substantially the form attached hereto for the period October 1, 2013 to
24		September 30, 2014; provided that the federal lobbying contract shall be
25		funded from the FY Economic Development Delegation Budget.
26		2. Authorizes the Chairman of the Nation to execute the federal lobbying
27		contract with the Attorneys.
