
1 **WHEREAS, the Office of Attorney General requires the legal services of the Wilmer Cutler**
2 **Pickering Hale and Dorr, LLP law firm ("Wilmer Hale") to represent the Tohono**
3 **O'odham Nation in matters relating to the West Valley Resort project; and**
4 **WHEREAS, the Attorney General has recommended an attorney contract for fiscal year 2014**
5 **for the period from October 1, 2013 to September 30, 2014; and**
6 **WHEREAS, the funding for this Attorney Contract will come from sources approved for such**
7 **purposes by the Legislative Council; and**
8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this**
9 **attorney contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
12 **with the Wilmer Hale law firm for FY2014, for the period from October 1,**
13 **2013 to September 30, 2014, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract will come from sources approved for**
15 **such purposes by the Legislative Council.**
- 16 **3. The Chairperson of the Nation is authorized to execute the Attorney**
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
19 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
20 **FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**
21 **Council Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by**
22 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**
