

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing Tohono O'odham Nation Delegation to the National Congress of American**  
**Indians' 2013 70<sup>th</sup> Annual Convention)**

**RESOLUTION NO. 13-387**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to consult with**  
2 **the federal government and other Indian tribes on all matters within the**  
3 **Council's authority (Constitution of the Tohono O'odham Nation, Article VI, 1(f));**  
4 **and**

5 **WHEREAS, the National Congress of American Indians ("NCAI") will hold its 2013 70<sup>th</sup> Annual**  
6 **Convention in Tulsa, Oklahoma from October 14-18, 2013; and**

7 **WHEREAS, the Tohono O'odham Nation has worked closely with the NCAI and with Indian**  
8 **tribes across the United States to address numerous national issues of**  
9 **importance to Indian people; and**

10 **WHEREAS, it is the best interest of the Tohono O'odham Nation to continue its national-**  
11 **level involvement in these issues by participating in the NCAI 2013 Annual**  
12 **Convention.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
14 **authorizes Chairman Ned Norris, Jr. to serve as the Nation's voting delegate and**  
15 **Legislative Chairman Timothy Joaquin to serve as the Nation's alternate voting**  
16 **delegate to the NCAI 2013 70<sup>th</sup> Annual Convention; provided that the voting**  
17 **delegate, alternate, and any Legislative Council representatives attending the**  
18 **NCAI Annual Convention are authorized to present and advocate for resolutions**  
19 **and positions previously approved by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup>**  
21 **day of SEPTEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**  
22 **FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**  
23 **Council Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by**  
24 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
26 **June 18, 1934 (48 Stat.984).**
