1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspelling in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 128-80, 06-**  
14 **81, 74-81, 86-82, 127-83, 184-83, 197-83, 54-88, 94-348, 95-341, 96-260, 96-383, 96-**  
15 **514, 97-144, 98-034, 98-174, 98-294, 98-357, 98-429, 99-004, 99-039, 99-140, 99-311,**  
16 **99-633, 2000-035, 2000-176, 2000-343, 2000-554, 01-050, 01-094, 01-263, 01-589,**
