1 **WHEREAS, the Tohono O'odham Nation has negotiated an Agreement with the City of**
2 **Tucson Public Safety Academy Training Facility on behalf of the Tohono**
3 **O'odham Police Department; and**

4 **WHEREAS, the TONPD will be utilizing the Southern Arizona Law Enforcement Training**
5 **Center (SALETC) Driving Track in conjunction with the Ranger Training School;**
6 **and**

7 **WHEREAS, the Domestic Affairs Committee has reviewed the Agreement and recommends**
8 **approval by the Tohono O'odham Legislative Council.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
10 **approves the Agreement between the Tohono O'odham Nation and the City of**
11 **Tucson Public Safety Academy Training Facility substantially in the form**
12 **attached hereto, and authorizes the Chairman of the Nation to execute it.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
14 **day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
15 **FOR; -0- AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
16 **Council by Article VI, Section 1 (c)(2); Section 1(f) the Constitution of the Tohono O'odham**
17 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
18 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
19 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
