5	WHEREAS,	the Tohono O'odham Legislative Council enacted Resolution No. 11-539;
6		accepting the award for the period of performance of October 1, 2011 though
7		March 31, 2013; and
8	WHEREAS,	a grant extension was approved and accepted by the Tohono O'odham
9		Legislative Council by Resolution No. 13-176 extending project end date to
10		March 31, 2014 and approved the FY 2014 budget; and
11	WHEREAS,	this budget amendment #1 will increase the Salary line item to provide for the
12		TON's 3% salary increase for Fiscal Year 2014 to be effective October 1, 2013; and
13	WHEREAS,	Operational has decreased to cover increase of salaries; and
14	WHEREAS,	the Indirect Cost has increased; and
15	WHEREAS,	the bottom line has not changed; and
16	WHEREAS,	the Tohono O'odham Nation Police Department has prepared a budget
17		amendment of which has been reviewed by the Budget Office, Grants &
18		Contracts, Executive Office, Domestic Affairs Committee and Budget & Finance
19		Committee of the Legislative Council have reviewed this budget and recommend
20		its approval and adoption.
21	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
22		approves the FY 2014 Budget Amendment 1 and attached hereto budget for the
23		program period of April 1, 2013 to March 30, 2014 for the DOJ, OJP Sex Offender
24		Registration, Tracking, Enforcement and Notification Division Grant, Grant No.
25		2011-AW-BX-0018, increasing Salaries by 3% on October 1, 2013, a decrease in
26		Operational, and an increase to Indirect cost with no change to bottom line.

28		the Chairman and any designated official to expend and administer the budget
29		as attached, provided that any amendments affecting the funds or funding level
