

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting October 23, 2013 Special Session for a Presentation from the Tohono  
O'odham Ki:Ki Association)

LEGISLATIVE ORDER NO. 13-406

1   **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2       **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3       **committees, boards and special committees." (Constitution of the Tohono**  
4       **O'odham Nation, Article VI, Section 1(a)); and**

5   **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6       **Council with the authority to "by majority vote, call for a special session"**  
7       **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8       **1.D.1): and**

9   **WHEREAS, the Housing Committee has requested a special session on October 23, 2013 for a**  
10       **presentation from the Tohono O'odham Ki:Ki Association and to address certain**  
11       **housing issues.**

12   **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
13       **special session on October 23, 2013 for a presentation from the Tohono O'odham**  
14       **Ki:Ki Association and to address certain housing issues.**

15   **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> day of**  
16   **OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
17   **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
18   **Article VI, Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19   **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20   **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
21   **June 18, 1934 (48 Stat.984).**
