

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 to the FY 2014 Tohono O'odham Health & Human Services
Division of Special Needs First Things First Family Support Child Development
Budget 600-14-6041)**

RESOLUTION NO. 13-408

1 **WHEREAS, the Tohono O'odham Nation has consistently supported the development of its**
2 **youngest members by providing for their welfare through various programs and**
3 **services designed to meet their special needs; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2014 Division of**
5 **Special Needs First Things First Family Support Child Development Budget in**
6 **the amount of \$292,690.00 with resolution No. 13-191; and**

7 **WHEREAS, the Division of Special Needs First Things First Family Support Child**
8 **Development is submitting a budget amendment to its FY 2014 budget to reflect**
9 **the cost of living 3% salary adjustment; and**

10 **WHEREAS, the 3% salary increase for the Division of Special Needs First Things First Family**
11 **Support Child Development for fiscal year 2014 will go into effect October 1st,**
12 **2013 as this is a crossover budget with the program period of July 1st, 2013 to**
13 **June 30th, 2014; and**

14 **WHEREAS, budget amendment will decrease operational expenses and budget total will**
15 **remain the same; and**

16 **WHEREAS, the Budget Office, Grants & Contracts, Executive, Health & Human Services**
17 **Committee and Budget & Finance committee of the Legislative Council have**
18 **reviewed this budget and recommend its approval and adoption.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
20 **approves Amendment #1 to adjust the salaries to the FY 2014 budget to reflect**
21 **the 3% cost of living increase effective October 1, 2013 for budget period July 1,**
22 **2013 to June 30, 2014. Budget total will remain the same in the amount of**
23 **\$292,690.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the budget,**
26 **as attached provided that any amendments affecting the funds or funding levels**
27 **of the budget shall be submitted for further prior approval by the Tohono**
28 **O'odham Legislative Council.**


