

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2014 Elder Abuse Prevention Grant Budget, \$82,237)**

**RESOLUTION NO. 13-409**

1 **WHEREAS, the Division of Adult Protective Services (APS) of the Tohono O'odham Nation,**  
2 **Health and Human Services was approved by the Tohono O'odham Legislative**  
3 **Council to provide services to abused, neglected and exploited elders and**  
4 **vulnerable adults; and**

5 **WHEREAS, the Nation was awarded an Administration on Aging Elder Abuse grant for three**  
6 **years; and**

7 **WHEREAS, a budget for year two of the grant has been prepared for FY 2014 with a program**  
8 **budget period of October 1, 2013 to September 30, 2014; and**

9 **WHEREAS, the budget will reflect the cost share of two positions Program Manager Senior**  
10 **salary at 10.14% with the Elder Abuse Prevention/Intervention Grant and 89.86%**  
11 **with APS Tribal Budget; and**

12 **WHEREAS, the Case Manager position will be cost shared with a salary at 56% with the Elder**  
13 **Abuse Prevention/Intervention Grant and 44% with APS Tribal Budget; and**

14 **WHEREAS, the Health and Human Services Committee and the Budget and Finance**  
15 **Committee of the Legislative Council have reviewed this budget and recommend**  
16 **its approval and adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
18 **approves the Elder Abuse Prevention/Intervention FY 2014 Grant budget in the**  
19 **amount of \$82,237 and attached hereto and approve:**

- 20 **1. Program Manager Senior salary position to be cost shared at 10.14% with the**  
21 **Elder Abuse Prevention/Intervention Grant and 89.86% with APS Tribal**  
22 **Budget.**
- 23 **2. Case Manger salary position to be cost shared 56% with the Elder Abuse**  
24 **Prevention/Intervention Grant and 44% with APS Tribal Budget.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the**  
27 **Budget as attached, provided that any Amendments affecting the funds or**  
28 **funding level is submitted for further prior approval by the Tohono O'odham**  
29 **Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council Article VI; Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
