

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2014 with California Indian Legal Services)

RESOLUTION NO. 13-412

1 WHEREAS, the Office of Attorney General continues to require the legal services of
2 California Indian Legal Services to represent the Tohono O'odham Nation in
3 legal proceedings in California involving the Nation's interests under the Indian
4 Child Welfare Act; and

5 WHEREAS, the Attorney General has proposed an attorney contract with California Indian
6 Legal Services for fiscal year 2014, for the period of October 1, 2013 to September
7 30, 2014, in the amount of \$60,000.00; and

8 WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the
9 attorney contract and recommend approval by the Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED THAT:

- 11 1. The Tohono O'odham Legislative Council approves an attorney contract with
12 California Indian Legal Services in the amount of \$60,000.00 for fiscal year
13 2014, for the period of October 1, 2013 to September 30, 2014, substantially in
14 the form attached hereto.
- 15 2. Funding for the attorney contract shall be provided from the operating
16 budget of the Office of Attorney General.
- 17 3. The Chairperson of the Nation is authorized and directed to execute the
18 attorney contract.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
20 day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5
21 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the
22 Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted
23 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
24 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
25 the Act of June 18, 1934 (48 Stat.984).
