1 WHEREAS. the Office of Attorney General continues to require the legal services of 2 California Indian Legal Services to represent the Tohono O'odham Nation in 3 legal proceedings in California involving the Nation's interests under the Indian 4 Child Welfare Act: and 5 WHEREAS. the Attorney General has proposed an attorney contract with California Indian 6 Legal Services for fiscal year 2014, for the period of October 1, 2013 to September 7 30, 2014, in the amount of \$60,000.00; and 8 WHEREAS. the Domestic Affairs and Budget & Finance Committees have reviewed the 9 attorney contract and recommend approval by the Legislative Council. 10 NOW, THEREFORE, BE IT RESOLVED THAT: 11 The Tohono O'odham Legislative Council approves an attorney contract with 12 California Indian Legal Services in the amount of \$60,000.00 for fiscal year 13 2014, for the period of October 1, 2013 to September 30, 2014, substantially in 14 the form attached hereto. 15 2. Funding for the attorney contract shall be provided from the operating 16 budget of the Office of Attorney General. 17 3.
