

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract for FY 2014 with Edward Johnson)**

RESOLUTION NO. 13-413

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Edward**
2 **Johnson to represent the Tohono O'odham Nation in legal proceedings in**
3 **Maricopa County, Arizona, involving the Nation's interests under the Indian**
4 **Child Welfare Act; and**

5 **WHEREAS, the Attorney General recommends an Attorney Contract with Edward Johnson in**
6 **the amount of \$35,000.00 for fiscal year 2014, for the period of October 1, 2013 to**
7 **September 30, 2014; and**

8 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the**
9 **attorney contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
12 **with Edward Johnson in the amount of \$35,000.00 for Fiscal Year 2014, for the**
13 **period of October 1, 2013 to September 30, 2014, substantially in the form**
14 **attached hereto.**
- 15 **2. Funding for the Attorney Contract shall be from the budget of the Office of**
16 **Attorney General.**
- 17 **3. The Chairperson of the Nation is authorized and directed to execute the**
18 **attorney contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
20 **day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
21 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
22 **Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**
23 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
24 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
25 **the Act of June 18, 1934 (48 Stat.984).**
