

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2014 with the Law Firm of Yoder & Langford, P.C.)

RESOLUTION NO. 13-415

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Yoder &**
2 **Langford, P.C., to represent the Tohono O'odham Nation in matters involving**
3 **Internal Revenue Service audits and investigations of the Districts and the**
4 **Nation, and matters related to retirement and pension plans; and**

5 **WHEREAS, the Attorney General recommended a budget of \$35,000.00 for fiscal year 2014,**
6 **for the period of October 1, 2013 to September 30, 2014; and**

7 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**
8 **Attorney General; and**

9 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed this**
10 **attorney contract and recommend approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 12 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
13 **with the law firm of Yoder & Langford in the amount of \$35,000.00 for FY**
14 **2014, for the period of October 1, 2013 to September 30, 2014, substantially in**
15 **the form attached hereto.**
- 16 **2. Funding for the attorney contract shall be provided from the budget of the**
17 **Office of Attorney General.**
- 18 **3. The Chairperson of the Nation is authorized and directed to execute the**
19 **attorney contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
21 **day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
22 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
23 **Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**
24 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
26 **the Act of June 18, 1934 (48 Stat.984).**
