

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2014 with the Law Firm of Dentons US LLP)**

RESOLUTION NO. 13-419

1 **WHEREAS, the Office of Attorney General require the legal services of the law firm of**
2 **Denton US LLP to represent the Tohono O'odham Nation in matters relating to**
3 **the West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract with Dentons US**
5 **LLP for FY 2014 for the period from October 1, 2013 to September 30, 2014; and**

6 **WHEREAS, the funding for this Attorney Contract will come from sources approved for such**
7 **purposes by the Legislative Council; and**

8 **WHEREAS, the Domestic Affairs and the Budget & Finance Committees have reviewed this**
9 **attorney contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
12 **with the law firm of Dentons US LLP for FY 2014, for the period of October 1,**
13 **2013 to September 30, 2014, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract will come from sources approved for such**
15 **purposes by the Legislative Council.**
- 16 **3. The Chairperson of the Nation is authorized and directed to execute the**
17 **attorney contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
19 **day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
20 **FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
21 **Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**
22 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
23 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
24 **the Act of June 18, 1934 (48 Stat.984).**
