

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Mrs. Mashone Antone to the Tohono O'odham Judicial Court)**

RESOLUTION NO. 13-420

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint**
2 **judges to the Tohono O'odham Judicial Court pursuant to the Constitution of the**
3 **Tohono O'odham Nation, ("Constitution") which states, "The Tohono O'odham**
4 **Courts shall be courts of record and shall consist of at least six (6) judges**
5 **appointed by the Tohono O'odham Council." (Constitution, Article VIII, Section**
6 **3); and**

7 **WHEREAS, the Constitution requires the judges' terms to be staggered so that two judges**
8 **shall be appointed every other year (Constitution, Article VIII, Section 4); and**

9 **WHEREAS, pursuant to 6 T.O.C. Chapter 1, Section 1103(B), "A judge shall continue in office,**
10 **even if the judge's term has expired, until a successor is appointed and sworn**
11 **in."; and**

12 **WHEREAS, Judge Regina Sixkiller resigned June 20, 2013, thereby leaving a vacancy for a**
13 **term expiring on January 31, 2019; and**

14 **WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to**
15 **the Tohono O'odham Judicial Court, has reviewed each judicial candidate's**
16 **application packet and background information, and has interviewed each**
17 **judicial candidate who submitted a complete application; and**

18 **WHEREAS, Mrs. Mashone Antone, an enrolled member of the Nation, has applied for**
19 **appointment to the Judicial Court; and**

20 **WHEREAS, the Legislative Council has likewise interviewed and considered each judicial**
21 **candidate appearing before the Council and recommends that the Council**
22 **appoint Mrs. Mashone Antone to a term ending January 31, 2019.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
24 **appoints Mrs. Mashone Antone as a Tohono O'odham Judicial Court judge for a**
25 **term beginning on the effective date of this resolution and ending January 31,**
26 **2019.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
28 **day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
29 **FOR; -0- AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
30 **Council Article VIII; Section 3 of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
