

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment to the Tohono O'odham Nation's "2013 Indian Housing Plan")**

**RESOLUTION NO. 13-424**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the authority "to promote, protect and provide for public health, peace,**  
3 **morals, education and general welfare of the Tohono O'odham Nation and its**  
4 **members" (Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally**  
6 **designated housing entity in accordance with the Native American Housing**  
7 **Assistance and Self-Determination Act of 1996, 25 U.S.C. §4101, et seq., P.L. 104-**  
8 **330, 110 Stat. 4016 ("NAHASDA"); and**

9 **WHEREAS, to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA**  
10 **requires submission of an annual Indian Housing Plan ("IHP") by the Indian**  
11 **tribe or by the tribe's designated housing entity (25 U.S.C. §4112); and**

12 **WHEREAS, pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham**  
13 **Code, Chapter 1, the TOKA shall submit annually to the United States**  
14 **Department of Housing and Urban Development's Southwest Area Office of**  
15 **Native American Programs ("SWONAP") the Nation's Indian Housing Plan after**  
16 **review and approval by Legislative Council resolution (TOKA Ordinance, Article**  
17 **IX, 1.a., [http://tolc-nsn.org/docs/Title 18Ch1.pdf](http://tolc-nsn.org/docs/Title%2018Ch1.pdf)); and**

18 **WHEREAS, under the direction of the TOKA's executive director, the TOKA prepared and**  
19 **submitted the Nation's "2013 Indian Housing Plan" for the program year**  
20 **beginning July 1, 2013 and ending June 30, 2014 to TOKA's Board of Directors for**  
21 **review and approval (TOKA Ordinance, Article IX, 1.b.ii.); and**

22 **WHEREAS, after approving the Nation's "2013 Indian Housing Plan" by Resolution No. 02-**  
23 **04-13, the TOKA's Board of Director's provided the IHP to the Legislative Housing**  
24 **Committee for review and approval (TOKA Ordinance, Article IX, 1.b.iii); and**

25 **WHEREAS, on March 23, 2013, the Legislative Council approved the Nation's "2013 Indian**  
26 **Housing Plan" for the program year beginning July 1, 2013 and ending June 30,**  
27 **2014 (Resolution No. 13-106); and**

28 **WHEREAS, any proposed amendments to the Nation's Indian Housing Plan shall be**  
29 **reviewed and approved by the Board, reviewed by the legislative oversight**  
30 **committee, and reviewed and approved by Legislative Council resolution before**  
31 **submission to the Southwest Office of Native American Programs (18 Tohono**  
32 **O'odham Code, Chapter 1, Article IX, 1.c.); and**

33 **WHEREAS, by TOKA Board Resolution No. 09-03-13, TOKA Board of Directors approved**  
34 **amendments to the Nation's "2013 Indian Housing Plan" to include a proposal to**

1 address unmet housing needs by applying for a loan from HUD's Title VI Tribal  
2 Housing Activities Loan Guarantee Program; and

3 WHEREAS, the Housing Committee recommends approval of the amendments to the  
4 Nation's "2013 Indian Housing Plan" to include the Title VI loan proposal, which  
5 would renovate 20 Sells rental units.

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it  
7 approves amendments to the Nation's "2013 Indian Housing Plan" to include the  
8 Title VI loan proposal to renovate 20 Sells rental units; provided that any  
9 additional amendments are subject to Legislative Council review and approval.

10 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes  
11 the Nation's Chairperson to sign the certification authorizing submission by the  
12 TOKA of amendments to the Nation's "2013 Indian Housing Plan."

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup>  
14 day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50  
15 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the  
16 Council by Article VI, Section 1 (c)(2) of the Constitution of the Tohono O'odham Nation,  
17 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
18 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
19 16 of the Act of June 18, 1934 (48 Stat.984).
