

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier Allottees Association FY 2014 Budget Utilizing Carryover funds
from the SAWRSA 9B Farm Cashout Fund)

RESOLUTION NO. 13-425

1 **WHEREAS, the 2004 Southern Arizona Water Rights Settlement Act (SAWRSA) Amendments,**
2 **P.L. 108-451, authorized the San Xavier District Council to elect to receive \$18.3**
3 **million in lieu of the federal government's obligation to construct the proposed**
4 **9B Farm on the San Xavier Indian Reservation (SAWRSA Amendments Section**
5 **304(c)(3)(A)(ii)); and**

6 **WHEREAS, the San Xavier District elected to receive the in lieu payment plus interest (9B**
7 **Farm Cashout Fund) (SXDC Resolution #10-09-10); and**

8 **WHEREAS, the San Xavier District Council approved a three-year budget from the 9B Farm**
9 **Cashout Fund totaling \$844,270.00 to fund the San Xavier Allottees Association**
10 **(SXAA) FY 2011 though FY 2013 activities and programs (SXDC Resolution #12-10-**
11 **12); and**

12 **WHEREAS, expenditures from the San Xavier 9B Farm Cashout Fund must be authorized**
13 **and approved by the San Xavier District Council and the Tohono O'odham**
14 **Legislative Council (SAWRSA Amendments Section 304(f)(1)(B)(i) and (ii)); and**

15 **WHEREAS, the San Xavier Allottees Association has completed its proposed activities and**
16 **budgets for FY 2011, FY 2012 and FY 2013 and has carryover (surplus) funds from**
17 **the 3 year allocation from the 9B Farm Cashout Fund; and**

18 **WHEREAS, the San Xavier Allottees Association wishes to utilize these carryover funds for**
19 **their FY 2014 Budget in the amount of \$238,996.71; and**

20 **WHEREAS, the San Xavier District Council has approved the SXAA Fiscal Year 2014 Budget**
21 **utilizing Carryover funds from the 9B Farm Cashout Fund Grant (SXDC**
22 **Resolution #10-13-01); and**

23 **WHEREAS, the Tohono O'odham Legislative Budget and Finance Committee reviewed the**
24 **SXAA Fiscal Year 2014 Budget totaling \$238,996.71 on October 17, 2013.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council, in**
26 **accordance with the SAWRSA Amendments and the Nation's Constitution hereby**
27 **approves the Fiscal Year 2014 SXAA Budget in the amount of \$238,996.71**
28 **utilizing Carryover fund from the SAWRSA 9B Farm Cashout Fund, provided that**

1 any change in funding purpose or amounts must be authorized by San Xavier
2 District Council resolution and approved by the Tohono O'odham Legislative
3 Council.

4 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD
5 day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5
6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the
7 Council by Section 1 (d)(i) and (1) of Article VI and Section 7 of Article IX of the Constitution of
8 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and
9 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
10 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




