

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Employment Rights Commission Budget of
\$328,466.66 for FY2014)**

RESOLUTION NO. 13-426

1 **WHEREAS, the O'odham Nation adopted the Employment Rights Ordinance No. 01-85**
2 **(Ordinance) which established the Tribal Employment Rights Commission, and**
3 **the Commission is charged with carrying out the terms of the Ordinance; and**

4 **WHEREAS, the Commission applies preference in contracting and employment under the**
5 **Ordinance; as amended, 13 T.O.C. Chapter 1; and**

6 **WHEREAS, the Ordinance, in Section 1111 provides for the collection of Employment Rights**
7 **Fees from all covered employers within the exterior boundaries of the Nation;**
8 **and**

9 **WHEREAS, the purpose of the Fees is to raise revenue for the operation of the Commission;**
10 **and**

11 **WHEREAS, in accordance with Section 1111(C) of the Ordinance, the TERO fees collected**
12 **shall be expended by the Commission pursuant to budgets duly approved by**
13 **Legislative Council to carry out the purposes of this Chapter; and**

14 **WHEREAS, the Commission was suspended on September 27, 2012 and suspension**
15 **extended on September 11, 2013 and the Nation's Chairperson was granted**
16 **authority to manage and take control of Commission finances; and**

17 **WHEREAS, the Office of the Chairman submits on behalf of the Commission the FY 2014**
18 **budget in the amount of \$328,466.66 which is the projected balance from FY**
19 **2013; and**

20 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
21 **Committee of the Legislative Council have reviewed this Budget and recommend**
22 **its approval and adoption.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
24 **approves the Tribal Employment Rights Commission FY-2014 Budget in the**
25 **amount of \$328,466.66 effective October 1, 2013 through September 30, 2014.**

26 **BE IT FURTHER RESOLVED any remaining balance of TERO Fee funds shall be carried over to**
27 **the next fiscal year, provided that such funds may only be expended in**
28 **accordance with an approved budget by this Council.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorize the**
30 **Tribal Employment Rights Commission and any designated official to expend**

1 and administer the budget in accordance with resolution 13-040, 13-093 through
2 13-096, as attached hereto, provided that any amendments affecting funds or
3 funding levels shall be submitted for further prior approval by Tohono O'odham
4 Legislative Council.

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD
6 day of OCTOBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5
7 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the
8 Council by Section 1 (d)(2)and(3) of Article VI of the Constitution of the Tohono O'odham
9 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the
10 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
11 Section 16 of the Act of June 18, 1934 (48 Stat.984).




