

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Department of Health and Human Services,
Division of Behavioral Health, FY 2014 Methamphetamine Suicide Prevention
Initiative (MSPI) Budget 200-14-6243)**

RESOLUTION NO. 13-429

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health**
2 **provides substance abuse, mental health, and prevention services; and**

3 **WHEREAS, the Tohono O'odham Nation has been awarded funds and operated the**
4 **Methamphetamine Suicide Prevention Initiative (MSPI) since August, 2009; and**

5 **WHEREAS, the MSPI purpose is to decrease the incidence of suicide and to increase the**
6 **suicide crisis response capacity of the Tohono O'odham Nation by training**
7 **gatekeepers in Applied Suicide Intervention Skills Training (ASIST) and by**
8 **enhancing the response to the surveillance, reporting and monitoring of the**
9 **Tohono O'odham Nation's members who are at risk for suicide; and**

10 **WHEREAS, the Tohono O'odham Nation Division of Behavioral Health was notified by IHS**
11 **on August 23, 2013 approving the Nation's request for Year 5 Funding in the**
12 **amount of \$163,485.00 to be expended September 1, 2013 through August 31,**
13 **2014; and**

14 **WHEREAS, the Tohono O'odham Nation accepts the FY 2014 MSPI award in the amount of**
15 **\$163,485.00; and**

16 **WHEREAS, this budget includes a 3% cost of living salary increase to be effective October 1,**
17 **2013 as this is a cross over budget with program period of September 1, 2013 to**
18 **August 31, 2014; and**

19 **WHEREAS, a decrease in operational expense will allow the 3% cost of living increase, with**
20 **no change to the budget total; and**

21 **WHEREAS, the Health and Human Services Committee and Budget and Finance Committee**
22 **of the Legislative Council have each reviewed this budget and notice of award**
23 **and recommend its approval and adoption.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 25 **1. To approve the Year 5 Methamphetamine Suicide Prevention Initiative**
26 **(MSPI) FY 2014 budget and award in the amount of \$163,485.00 to be utilized**
27 **September 1, 2013 through August 31, 2014.**
- 28 **2. This budget reflects a 3% cost of living increase to be effective October 1,**
29 **2013, and that a decrease in Operational Expense will allow no change to the**
30 **budget total of \$163,485.00.**

11 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
12 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
