9		been assigned an enrollment number may, for a period of three years
10	:	from the effective date of this chapter, change that member's regional
11		reference, or the regional reference of an enrolled minor on behalf of
12		whom the member has the legal authority to act, to the new Hia-Ced
13		District using the initials "HC."; and
14	WHEREAS,	enrolled members have three years from October 30, 2012, the effective date of
15		the ordinance, to change a regional reference; and
16	WHEREAS,	the members identified in the attached November 2013 Regional Reference
17		Change list have requested a regional reference change in accordance with the
18		creation of the Hia-Ced District ordinance.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
20		the regional reference changes and new enrollment numbers for the members
21		identified in the attached November 2013 Regional Reference Changes list.
