1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
11 **approving applicants for membership contain misspellings in the names of**
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 77-80, 115-**
14 **82, 36-85, 03-90, 97-256, 98-034, 98-123, 98-294, 98-429, 98-461, 99-004, 99-360,**
15 **2000-035, 2000-397, 01-050, 01-094, 02-003, 03-100, 03-153, 07-075, 09-008, 10-**
16 **070, 12-260, 13-109 and 13-331 be amended to reflect the correct name spelling**
17 **or roll numbers for the individuals identified in the Amending Enrollment**
18 **Resolution List November 2013, which is incorporated by this reference.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
20 **Resolution Nos. 77-80, 115-82, 36-85, 03-90, 97-256, 98-034, 98-123, 98-294, 98-**

22 **03-153, 07-075, 09-008, 10-070, 12-260, 13-109 and 13-331 are amended upon the**
23 **effective date of those resolutions to reflect the corrected names or roll**
24 **numbers that are identified in the Amending Enrollment Resolution List**
25 **November 2013.**

27 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**

31 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
32 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




