10	WHEREAS,	through internal assessments and evaluations, it was determined, that
11		specialized staff sustainment is necessary to continue enhanced program
12		development, maintain and continue the advancement of operational
13		improvements. To do so, it's necessary to reclassify the position of Senior
14		Accountant to Geographic Information Systems (GIS) Analyst; and
15	WHEREAS,	the Tohono O'odham Legislative Council approved through Resolution No. 13-
16		277 the FY 2014 Office of Emergency Management Budget in the amount of
17		\$608,575.77; and
18	WHEREAS,	the FY 2014 Budget total combined operational and personnel budget of
19		\$608,575.77 did not change. Changes were made to Salary and Operational line
20		items per the attached Budget to incorporate acquired heavy equipment and the
21		Salary adjustments incurred as a result of the Reclassification; and
22	WHEREAS,	the Domestic Affairs Committee and the Budget & Finance Committee of the
23		Legislative Council have reviewed this budget and recommend its approval and
24		adoption.
25	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
26		and accepts Budget Amendment #1 of the DPS-Office of Emergency Management
27		FY 2014 Budget with no changes to the total budget, and approved as presented
