7		per dispatched call; and			
8	WHEREAS,	the parties have agreed to continue the mutually beneficial arrangement for an			
9		additional year, and to execute a new Emergency Dispatch Services Agreement;

11	WHEREAS,	the agreement shall be in effect for the time period October 1, 2013 to September			
12		30, 2014; and			
13	WHEREAS,	the Domestic Affairs Committee and the Budget and Finance Committee have			
14		reviewed the proposed agreement and recommend approval by the Legislative			
15		Council.			
16	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the			
17		Emergency Dispatch Services Agreement with the Drexel Heights Fire District
