

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Emergency Dispatch Services Agreement Between the Nation and Drexel Heights Fire District for FY 2014)

RESOLUTION NO. 13-440

1 **WHEREAS, the Tohono O'odham Nation entered into an intergovernmental agreement**
2 **called an emergency Dispatch Services Agreement with the Drexel Heights Fire**
3 **District on or about August 16, 2002, and it has been extended annually; and**

4 **WHEREAS, under the Emergency dispatch Services Agreement, the Drexel Heights Fire**
5 **District provides emergency dispatch services to the Tohono O'odham Nation**
6 **Fire Department for the Nation's San Xavier District at an agreed price of \$30.25**
7 **per dispatched call; and**

8 **WHEREAS, the parties have agreed to continue the mutually beneficial arrangement for an**
9 **additional year, and to execute a new Emergency Dispatch Services Agreement;**
10 **and**

11 **WHEREAS, the agreement shall be in effect for the time period October 1, 2013 to September**
12 **30, 2014; and**

13 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have**
14 **reviewed the proposed agreement and recommend approval by the Legislative**
15 **Council.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **Emergency Dispatch Services Agreement with the Drexel Heights Fire District**
18 **substantially in the form attached hereto and authorizes the Chairman of the**
19 **Tohono O'odham Nation to execute it and any further amendments extending**
20 **the term of the agreement.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
22 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
23 **FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**
24 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted**
25 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
27 **the Act of June 18, 1934 (48 Stat.984).**
