RESOLUTION NO. 13-441

1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded the Department of**
2 **Justice (DOJ) Office of Justice (OJP) Office of Juvenile Justice and Delinquency**
3 **Prevention (OJJDP) Youth Mentoring Program (YMP) grant; and**

4 **WHEREAS, the Tohono O'odham Legislative Council (TOLC) enacted TOLC Resolution No. 11-**
5 **541 accepting the YMP grant award; and**

6 **WHEREAS, the grant is effective October 1, 2011 through September 30, 2014; and**

7 **WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget for the**
8 **FY 2014 budget year, which has been reviewed by the Budget Office, Grants &**
9 **Contracts, Executive Office, Domestic Affairs Committee and the Budget &**
10 **Finance Committee, of all which recommend acceptance by the Tohono**
11 **O'odham Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby,**
13 **approves the FY 2014 budget of the DOJ/OJP/OJJDP Youth Mentoring Grant.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
15 **the Chairman and any designated official to expend and administer the budget**
16 **as attached, provided that any amendments affecting the funds or funding level**
17 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
18 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
20 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
21 **FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**
22 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted**
23 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
24 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
25 **the Act of June 18, 1934 (48 Stat.984).**
