RESOLUTION NO. 13-442

1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded the Department of**
2 **Justice (DOJ) Office of Justice (OJP) Bureau of Justice Assistance (BJA), Tohono**
3 **O'odham Nation (TON) Resource Center grant; and**

4 **WHEREAS, the grant was accepted by the Tohono O'odham Legislative Council (TOLC)**
5 **enacted TOLC Resolution No. 11-542 accepting the TON Resource Grant; and**

6 **WHEREAS, the grant effective dates were from October 1, 2011 through September 30, 2014;**
7 **and**

8 **WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget, the FY**
9 **2014 budget year, which has been reviewed by the Budget Office, Grants &**
10 **Contracts, Executive Office, Domestic Affairs Committee and the Budget &**
11 **Finance Committee of the Legislative Council have reviewed this Budget and**
12 **recommend its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby,**
14 **approves the FY 2014 budget of the DOJ/OJP/BJA TON Resource Grant in the**
15 **amount of \$168,289.76.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
17 **the Chairman and any designated official to expend and administer the budget**
18 **as attached, provided that any amendments affecting the funds or funding level**
19 **is submitted for further prior approval by the Tohono O'odham Legislative**
20 **Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
22 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
23 **FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the**
24 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted**
25 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
27 **the Act of June 18, 1934 (48 Stat.984).**
