

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the List of Traditional O'odham Leaders of the O'odham in Mexico Communities)

RESOLUTION NO. ~~13-444~~

1 **WHEREAS, in 1995 the Tohono O'odham Legislative Council adopted Resolution No. 95-562,**
2 **"Recognition of the O'odham in Mexico communities and Traditional**
3 **government in order to address issues for Tohono O'odham members who**
4 **reside on Tohono O'odham ancestral land in Mexico; and**

5 **WHEREAS, Resolution No. 95-562 approved a list of Traditional O'odham Leaders in Mexico,**
6 **and the list was updated by Resolution 05-725 to reflect "representatives have**
7 **either resigned, expired or no longer can serve in their official capacity and in**
8 **some cases new representatives have been appointed since 1995"; and**

9 **WHEREAS, on August 8, 2013 enrolled members of the Tohono O'odham Nation within the**
10 **traditional O'odham community Pitiquito, Sonora selected a leader and**
11 **alternate to represent the Pitiquito community.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **amend the list of Traditional O'odham Leaders approved by Resolution No. 05-**
14 **725 to add the following community and representatives:**

15 **PITIQUITO**

16 **Representative Francisca Salas Rodriguez**

17 **Alternate Maria del Carmen Salas Rodriguez**

18 **BE IT FINALLY RESOLVED that all matters affecting O'odham in Mexico will be presented to the**
19 **Traditional O'odham Leaders who have the responsibility for determining their**
20 **issues and any and all matters will be presented to the Tohono O'odham Nation**
21 **Government through the Governor and/or the Lieutenant Governor in his**
22 **absence.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
24 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,685.90**
25 **FOR; -0- AGAINST; 260.6[02] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in**
26 **the Council by Article VI, Section 1 (c)(8) and Article XVI, Section 9 of the Constitution of the**
27 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
28 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
29 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
