

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting November 26, 2013 Special Session for Tour of and Presentation By the Tohono
O'odham Judicial Branch)**

LEGISLATIVE ORDER NO. 13-452

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**
6 **Council with the authority to "by majority vote call for a special session"**
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**
8 **1.D.1.); and**


9 **WHEREAS, Article I, Section 2.,(C) of the Legislative Rules of the Tohono O'odham Legislative**
10 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be**
11 **held at the Tohono O'odham Legislative Council chambers located in Sells,**
12 **Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the**
13 **legislative representatives may vote to hold a session in some location other**
14 **than the chambers located at Sells."; and**

15 **WHEREAS, the Judiciary Committee has requested a special session on November 26, 2013**
16 **for a tour of the Judicial Branch in the morning and an afternoon presentation**
17 **in Legislative Council chambers by the Judicial Branch.**

18 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
19 **special session on November 26, 2013 for a tour of the Judicial Branch and roll**
20 **call at 9 a.m. and an afternoon presentation by the Judicial Branch in Legislative**
21 **Council chambers.**

22 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH day of**
23 **NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
