RESOLUTION NO. 13-453

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Senior Services**
2 **program for the Elders of the Nation; and**

3 **WHEREAS, funding for Title VII Long Term Care Services (LTCS) Advocacy is possible in part**
4 **by Title III of the Older Americans Act funds administered through the Inter-**
5 **Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the Tohono O'odham Nation Senior Services has prepared a new FY 2014 Title VII**
7 **Long Term Care Services (LTCS) Advocacy budget of \$10,000.00 that will allow a**
8 **staff member to become a certified Ombudsman; and**

9 **WHEREAS, the certified Ombudsman will be a specially trained advocate who seeks to**
10 **resolve complaints on behalf of residents of long term care facilities; including**
11 **assistant living and skilled nursing facilities; and**

12 **WHEREAS, the Health and Human Services Committee and Budget and Finance Committee**
13 **of the Legislative Council has reviewed the attached budget and recommends its**
14 **approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
16 **approves:**

17 **The Tohono O'odham Nation Senior Services FY 2014 Title VII Long Term Care**
18 **Services (LTCS) Advocacy \$10,000.00 budget that allows a staff member to**
19 **become a certified Ombudsman and be a specially trained advocate that seeks**
20 **to resolve complaints on behalf of residents of long term care facilities;**
21 **including assistant living and skilled nursing facilities.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislative**
26 **Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
28 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**
29 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
30 **Council by Article VI, Section 1 (d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
33 **16 of the Act of June 18, 1934 (48 Stat.984).**
