

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for 401 (K) Matters with Yoder & Langford, P.C. for FY 2014)

RESOLUTION NO. 13-454

1 **WHEREAS, the Tohono O'odham Nation has for several years contracted with the law firm of**
2 **Yoder & Langford, P.C. for legal services related to the 401(k) Plan of the Nation**
3 **to assist the 401(k) Trustees and the Human Resources Office; and**
4 **WHEREAS, the Attorney Contract for 401(k) is under the oversight of the Attorney General,**
5 **but is paid for out of the 401(k) budget of the Human Resources Office; and**
6 **WHEREAS, the last such Attorney Contract expired on September 30, 2013; and**
7 **WHEREAS, it is in the best interest of the Nation to continue representation by the Attorney;**
8 **and**
9 **WHEREAS, the Human Resources Officer and the Attorney General recommend an Attorney**
10 **Contract with the Attorney in the amount of \$15,000 for the period of October 1,**
11 **2013 through September 30, 2014; and**
12 **WHEREAS, the 401(k) Trustee budget has sufficient funds for the contract amount; and**
13 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
14 **Committee recommend approval by the Legislative Council of the Attorney**
15 **Contract.**

16 **NOW, THEREFORE, BE IT RESOLVED that:**

- 17 **1. The Tohono O'odham Legislative Council approves the Attorney Contract for**
18 **401(K) matters with the law firm of Yoder & Langford, P.C., in the amount of**
19 **\$15,000.00 for the period of October 1, 2013 through September 30, 2014**
20 **substantially in the form attached hereto.**
- 21 **2. Funding for the Attorney Contract shall be provided from the 401(K) Trustee**
22 **budget.**
- 23 **3. The Chairman of the Nation or any authorized official is directed to execute**
24 **the Attorney Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
26 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
27 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
28 **Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
31 **the Act of June 18, 1934 (48 Stat.984).**
