

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Clark Law Firm)

RESOLUTION NO. 13-455

1 **WHEREAS, it is advisable that the Human Resources Office has available independent legal**
2 **representation for employment issues in which the Office of Attorney General is**
3 **unable to provide legal advice due to conflicts of interest; and**

4 **WHEREAS, the Human Resources Office recommends an Attorney Contract with The Clark**
5 **Law Firm to provide legal representation to the Human Resources Office for the**
6 **foregoing purposes; and**

7 **WHEREAS, the proposed Attorney Contract is in the amount of \$23,000.00 for the period**
8 **from October 01, 2013 through September 30, 2014; and**

9 **WHEREAS, the operating budget for the Human Resources Office (Account No. 001-14-2530-**
10 **7355) for fiscal year 2014 includes sufficient funds for the Attorney Contract; and**

11 **WHEREAS, the Human Resources Development and Budget and Finance Committees**
12 **recommend approval by the Legislative Council of an attorney contract.**

13 **NOW, THEREFORE, BE IT RESOLVED that:**

- 14 **1. The Tohono O'odham Legislative Council hereby approves an Attorney**
15 **Contract with the Clark Law Firm in the amount of \$23,000.00 for the Fiscal**
16 **Year ending September 30, 2014, and in the form attached hereto.**
- 17 **2. Funding for the Attorney Contract in fiscal year 2014 shall be provided**
18 **under the operating budget of the Human Resources Office (Account No.**
19 **001-14-2530-7355.**
- 20 **3. The Chairman of the Nation is authorized and directed to execute the**
21 **Attorney Contract.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
23 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**

25 **Council by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
28 **the Act of June 18, 1934 (48 Stat.984).**
