

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2014 Legislative Branch Budget Amendment No. 1)

RESOLUTION NO. 13-456

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation... and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution**
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section**
6 **1(d)(2)); and**

7 **WHEREAS, the Legislative Branch FY 2014 budget was approved by Resolution No. 13-279;**
8 **and**

9 **WHEREAS, the Legislative Branch administration has prepared and submitted for review**
10 **and approval its FY 2014 Budget Amendment No. 1 in the amount of \$45,452.72**
11 **from salary saving to increase line items 6005-Occasional Appointments by**
12 **\$6,500.00; 7005-Supplies - Office Equipment by \$14,000.00; 7400-RM Equipment**
13 **by \$6,952.72; 7430-RM Ground by \$10,000.00; and 8060-Alteration/Renovations**
14 **by \$8,000.00; and**

15 **WHEREAS, the FY 2014 Legislative Branch Budget Amendment No. 1 has sufficient funds in**
16 **the Legislative Branch FY 14 budget to support the proposed Legislative Branch**
17 **FY 2014 Budget Amendment No. 1; and**

18 **WHEREAS, the Legislative Branch FY 2014 Budget Amendment No. 1 has been reviewed by**
19 **the Budget and Finance Committee and recommends approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
21 **approves the FY 2014 Legislative Branch Budget Amendment No. 1, Attached**
22 **hereto.**


23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation Legislative Council Chairman and Vice-Chairman are**
25 **authorized to administer the attached budget, provided however, that any**
26 **amendments affecting these funds or funding levels budgeted shall be**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
29 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5**
30 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
31 **Council by Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
34 **16 of the Act of June 18, 1934 (48 Stat.984).**




