**RESOLUTION NO. 13-461**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 12-383 on**  
2 **September 20, 2012, "Approving FY 2013 Sif-Oidak District Gaming Revenue**  
3 **Budget in the amount of \$1,202,486.94"; and**

4 **WHEREAS, Sif Oidak District Council, at a regular meeting held on October 12, 2013 passed**  
5 **Resolution No. SODC 13-132, "Approving the Sif-Oidak District FY 2013 Surplus**  
6 **Budget in the amount of \$135,332.02"; and**

7 **WHEREAS, the Sif-Oidak District Council, at a regular meeting held on October 26, 2013**  
8 **passed Resolution No. SODC 13-138, "Amending Resolution No. SODC 13-132 to**  
9 **revise the heading to Approving the Sif-Oidak District FY 2014 Gaming Revenue**  
10 **Surplus Budget from FY 2013 in the amount of \$135,332.02"; and**

11 **WHEREAS, the Surplus Budget is utilizing the fiscal year 2013 remaining funds in the**  
12 **amount of \$135,332.02, per the attached budget; and**

13 **WHEREAS, the Legislative Budget & Finance Committee did review the attached Sif Oidak**  
14 **District FY 2014 Gaming Revenue Surplus Budget from FY 2013 in the amount of**  
15 **\$135,332.02 on October 24, 2013 and recommends approval.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**  
17 **hereby approve the Sif-Oidak District FY 2014 Gaming Revenue Surplus Budget**  
18 **from FY 2013 as attached in the amount of \$135,332.02.**

19 **BE IT FURTHER RESOLVED that the Surplus Budget will be retroactive to October 1, 2013.**

20 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or**  
21 **funding levels that it shall be approved by the Tohono O'odham Legislative**  
22 **Council prior to any expenditures.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
24 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**  
25 **FOR; -0- AGAINST; -0- NOT VOTING; and [05]ABSENT, pursuant to the powers vested in the**  
26 **Council by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation,**  
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
29 **16 of the Act of June 18, 1934 (48 Stat.984).**
