(Approving the Sif-Oidak District FY 2014 Mining Budget in the Amount of \$509,500.00)

RESOLUTION NO. 13-462

1 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 12-352 on**
2 **September 11, 2012, "Approving the FY 2013 Sif-Oidak District Community**
3 **Services Budget in the amount of \$541,000.00"; and**

4 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 12-502 on**
5 **December 19, 2012, "Approving the FY 2013 Sif-Oidak District Community**
6 **Services Budget Amendment No. 1 in the amount of \$42,750.00"; and**

7 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 13-268 on July**
8 **18, 2013, "Approving the FY 2013 Sif-Oidak District Community Services Budget**
9 **Amendment No. 2 in the amount of \$238,513.00"; and**

10 **WHEREAS, the Sif-Oidak District Council, at a regular meeting held on October 12, 2013,**
11 **passed Resolution No. 13-133, "Approving the Sif-Oidak District FY 2014 Mining**
12 **Budget"; and**

13 **WHEREAS, the Mining Budget is utilizing the fiscal year 2013 remaining funds in the**
14 **amount of \$204,642.24 and \$304,857.76 in new Mining funds for a total of**
15 **\$509,500.00; and**

16 **WHEREAS, the Legislative Budget and Finance Committee did review the attached Sif-Oidak**
17 **District FY 2014 Mining Budget on October 24, 2013 and recommends approval.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council, that it does**
19 **hereby approve the Sif-Oidak District FY 2014 Mining Budget in the amount of**
20 **\$509,500.00.**

21 **BE IT FURTHER RESOLVED that the Mining budget includes \$204,642.24 of FY 2013 remaining**
22 **funds and \$304,857.76 of new funds.**

23 **BE IT FURTHER RESOLVED that the amount of \$304,857.76 will be disbursed from the Mining**
24 **Funds held by the Tohono O'odham Nation Treasury.**

25 **BE IT FURTHER RESOLVED that the Mining Budget will be retroactive to October 1, 2013.**

26 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or**
27 **funding levels that it shall be approved by the Tohono O'odham Legislative**
28 **Council prior to any expenditures.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
30 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**
31 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
32 **Council by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation,**
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
34 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
35 **16 of the Act of June 18, 1934 (48 Stat.984).**
