1 **WHEREAS, the Tohono O'odham Legislative Council passed on February 7, 2013, Resolution**
2 **No. 13-052, "Approving the Sif-Oidak District FY 2006 Carryover Budget in the**
3 **amount of \$349,291.06"; and**

4 **WHEREAS, the Tohono O'odham Legislative Council passed on February 7, 2013, Resolution**
5 **No. 13-053, "Approving the Sif Oidak District FY 2012 APS Carryover Budget in the**
6 **amount of \$35,825.00"; and**

7 **WHEREAS, the FY 2013 Arizona Public Service (APS) surplus amount of \$19,031.30 and the FY**
8 **2006 Carryover surplus amount of \$325,773.94 have been combined into the new**
9 **capital budget for FY 2014; and**

10 **WHEREAS, the Sif-Oidak District FY 2014 Capital Budget is as follows: (810) Professional**
11 **Services - \$344,805.24 with a grand total of \$344,805.24; and**

12 **WHEREAS, the Legislative Budget and Finance Committee reviewed the Sif-Oidak District**
13 **FY 2014 Capital Budget on October 24, 2013 and recommends approval.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council hereby**
15 **approve the Sif-Oidak District FY 2014 Capital Budget in the amount of**
16 **\$344,805.24.**

17 **BE IT FURTHER RESOLVED that this budget shall be retroactive to October 1, 2013.**

18 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or**
19 **funding levels that it shall be approved by the Tohono O'odham Legislative**
20 **Council prior to any expenditures.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
22 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**
23 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
24 **Council by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation,**
25 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
27 **16 of the Act of June 18, 1934 (48 Stat.984).**
